REQUEST TO EXTEND THE TIME TO APPLY TO INTERVENE**

Dear President Fiordaliso:

Please accept this correspondence with regard to the above-referenced matter. The undersigned represents the Borough of Stone Harbor as Solicitors.

Upon information and belief, on June 29, 2022, the Board of Public Utilities ("BPU") entered an Order in this matter, made effective Friday, July 1, 2022. The Order contains a provision that any party seeking to intervene in the matter must do so on or before July 15, 2022. Upon reviewing the issues at hand and considering the import of the application of the above-referenced statute, the Borough of Stone Harbor has a significant interest in the matter and may considering intervening in the same.

At present, the timeframe of the Order has made it exceedingly difficult for the Borough to consider the issues raised therein and submit a motion, should that determination be made, by July 15, 2022. Prior to making any such determination, it is also necessary to have the same considered and discussed by the governing body. Unfortunately, the next meeting of the governing body is not scheduled until after the July 15, 2022 deadline.

Accordingly, on behalf of the Borough of Stone Harbor, I hereby request that that the BPU amend the aforementioned order to postpone the deadline for the filing a Motion to Intervene so that the Borough, as an interested party, may thoroughly vet and consider the issues at hand. It is respectfully submitted that the granting of such a request would not cause any significant delay
