Be advised that the undersigned serves as the Solicitor for the Township of Dennis (hereinafter referred to as "Township"), County of Cape May. Please accept this letter in lieu of a more formal request on behalf of the Township to extend the time to apply for intervention in the above captioned matter. On June 29, 2022, the Board of Public Utilities entered an Order in the above referenced matter, effective Friday, July 1, 2022, which stated, in part, that any party seeking to intervene must do so on or before July 15, 2022.

As you are aware, the outcome of the pending petition has potential implications for all sixteen (16) municipalities within Cape May County, including the Township. As such, the Township is currently contemplating filing a Motion to Intervene. However, prior to making a determination as to the proper course of action, the governing body of the Township will have to meet and discuss the same. In keeping the July 15, 2022 date as the deadline for potential parties to file for intervention, the Township would be prejudiced insomuch as it would be nearly impossible for them to decide the proper course of action and to draft the appropriate Motion paperwork within the limited timeframe provided by the Board of Public Utilities.
