Dear Sirs/Madams

Please be advised that this office serves as legal counsel to the Township of North Brunswick ("Township"). The Township is in the final stages of the administration and procurement process associated with the above referenced Public-Private Partnership Agreement ("Agreement") with Veolia Water North America Operating Services, LLC ("Veolia") for the provision of water supply services. Please accept this letter and application as the Township's intent to be heard at the New Jersey Board of Public Utilities meeting on September 7, 2022.

On February 7, 2022 the Township Council authorized the Township to solicit proposals from qualified vendors for a public-private partnership agreement for the operation, maintenance,

management, and repair services for the Township's municipal water system in accordance with the New Jersey's Water Supply Public-Private Contracting Act, N.J.S.A. 58:26-19, et. seq. The Township received one (1) proposal from Veolia. On June 27, 2022, the Township Council adopted Resolution No. 202-6.22 and accepted the bid from Veolia and awarded a contract for the operation, maintenance, management, and repair services for the Township's water system (See Resolution No. 202-6.22 attached hereto as Exhibit E).

However, pursuant to N.J.S.A. 58:26-25, the Township's acceptance of this contract must be approved via Ordinance. The Township conducted a first reading of Ordinance No. 22-18 to award an Agreement with Veolia on August 1, 2022. (See Ordinance No. 22-18 attached hereto as Exhibit E). Moreover, the Township conducted a public hearing on Monday, July 25, 2022 at 7:00 p.m.. (See Affidavits of Publication attached hereto as Exhibit F). The verbatim transcripts are included with this application. (See Transcripts attached as part of the Hearing Report's Exhibit C). It is important to note that no comments, statements, or questions were presented by any members of the public. In addition, during the seven (7) day that the record was held open after the public hearing, no written statements were submitted by any interested parties. Lastly, at this public hearing the Township Council adopted Resolution No. 239-8.22 permitting the Township to submit an application to the Local Finance Board and the Board of Public Utilities, (See Resolution No. 239-8.22 attached hereto as Exhibit G).
