On July 27, 2022, New Jersey-American Water Company, Inc. (the "Company") submitted revised tariff leaves in compliance with Ordering Paragraph number 8 of the Board's Order issued July 13, 2022, and effective July 20, 2022, approving the municipal consent in the above-referenced matter. The tariff leaves were issued with an effective date of August 1, 2022, in anticipation of the closing happening on that date.

The closing on the assets of the Borough of Bound Brook has been delayed, and the Company respectfully requests that the tariff revisions submitted on July 27, 2022 be withdrawn, and an extension of time be granted for the filing of revised tariff leaves to 5 business days after closing, which the parties anticipate will occur on August 11th.
