We represent Petitioner Rockland Electric Company. We hereby request a suspension of the procedural schedule set forth in your August 24, 2022 Order Amending Procedural Schedule. This request has been consented to by the Division of Rate Counsel and Board Staff, who are the other two parties to the proceeding. The basis for the request is the desire among the parties to complete the settlement process. The parties have held settlement meetings pursuant to the schedule and have reached an agreement in principle. However, additional time is needed to develop detailed settlement terms and set them forth in an agreed-upon Stipulation.
