

**NOTICE OF FILING OF A JOINT PETITION FOR APPROVAL OF
THE ACQUISITION OF SOUTH JERSEY INDUSTRIES, INC., AND ITS PUBLIC
UTILITY SUBSIDIARIES, ELIZABETHTOWN GAS AND SOUTH JERSEY GAS
COMPANY, BY BOARDWALK MERGER SUB, INC.**

NOTICE OF PUBLIC COMMENT HEARINGS

PLEASE TAKE NOTICE that on April 25, 2022, IIF US Holding 2 LP (“IIF US 2”), NJ Boardwalk Holdings LLC (“Boardwalk”), Boardwalk Merger Sub, Inc. (“Merger Sub”), South Jersey Industries, Inc. (“SJI”), SJI Utilities, Inc., Elizabethtown Gas Company (“ETG”) and South Jersey Gas Company (“SJG”) (collectively, “Joint Petitioners”) submitted a Joint Petition (“Joint Petition”) to request approval by the New Jersey Board of Public Utilities (“Board” or “BPU”), pursuant to N.J.S.A. 48:2-51.1 and N.J.A.C. 14:1-5.14(c), of an indirect change of control of ETG and SJG. The proposed transaction entails the merger of SJI with Merger Sub, a wholly-owned subsidiary of Boardwalk, with SJI remaining as the surviving entity (“Proposed Acquisition”). Boardwalk is a wholly-owned subsidiary of IIF US 2. Upon completion of the Proposed Acquisition, SJI would be privately held and there will be an indirect change of control of ETG and SJG.

As described in the Joint Petition, no rate changes are proposed in connection with the Proposed Acquisition. ETG and SJG will continue to provide utility service to customers pursuant to their current BPU-approved tariffs at the current rates and terms and conditions of service. The Joint Petitioners have also made a number of commitments in connection with the Proposed Acquisition, including the following: the maintenance of SJI’s headquarters in New Jersey; \$15 million in a one-time customer rate credit; charitable contributions totaling at least \$2 million over five years; a total of \$1 million in contributions to NJ SHARES or LIHEAP over five years; ring-fencing and governance provisions; and no material involuntary acquisition-related workforce reductions or changes to wages, benefits and other terms and conditions of employment for five years.

The Board will evaluate the impact of the Proposed Acquisition on competition, the rates paid by ETG and SJG’s customers, the employees of ETG and SJG, and the provision of safe and adequate utility service at just and reasonable rates. The Joint Petitioners state that the proposed Acquisition will not have an adverse impact on competition, rates, employees of ETG and SJG, or on the provision of safe, adequate and proper utility service, and instead will provide positive benefits for ETG and SJG, as well as their customers and the State of New Jersey as demonstrated by the commitments included in the Joint Petition.
