As noted in our October 3, 2022 Application for Approval of the above referenced Services Agreement, this office serves as legal counsel to the Borough of Fair Lawn (the "Borough"). Please accept this as a consent to the New Jersey Board of Public Utilities' ("NJBPU") request to extend its statutorily authorized review timeframe by several days to December 7, 2022.

The NJBPU, via electronic email dated October 11, 2022 has requested that the Borough consent to the extension of the NJBPU's review timeframe by several days to accommodate the timing of the NJBPU's Board of Commissioners meeting scheduled for December 7, 2022. The Borough consents to this extension of time. If the LFB intends to consider the Application for Approval at its December 14, 2022 monthly meeting, then the City also consents to an extension of the LFB's statutory review period to December 14, 2022.
