On October 20, 2022, Public Service Electric and Gas Company ("PSE&G" or the "Company"), filed a letter petition with the New Jersey Board of Public Utilities ("Board") requesting a three-year extension of the Company's current CSG Service Agreement with Marcal Manufacturing, LLC formerly d/b/a Soundview Paper Company, LLC ("Marcal"). PSE&G understands that the New Jersey Division of Rate Counsel ("Rate Counsel") needs additional time to review Marcal's petition and to conduct discovery as necessary.
