TO THE HONORABLE COMMISSIONERS OF THE NEW JERSEY BOARD OF PUBLIC UTILITIES:

VERIFIED JOINT PETITION

Manhattan Telecommunications Corporation of New Jersey ("Manhattan Telecommunications Corporation NJ") and Manhattan Telecommunications Corporation of New Jersey LLC ("Manhattan Telecommunications NJ LLC") (together, the "Petitioners"), to the extent necessary pursuant to N.J.S.A. 48:3-7 and 48:3-10, request Board approval for an internal, pro forma restructuring. Manhattan Telecommunications Corporation NJ merged with its affiliate, Manhattan Telecommunications NJ LLC, with Manhattan Telecommunications NJ LLC being the surviving entity (the "Transaction"). The Transaction is part of a conversion of MetTel operating companies from corporations to limited liability companies. Following completion of the conversion of all the MetTel operating companies, an intermediate holding company was inserted between Petitioners' parent company, Metropolitan Telecommunications Holding Company LLC ("MetTel Holding"), and their ultimate parent company, MetTel, Inc.

¹ As part of the conversion of MetTel entities, MetTel Holding also converted from a corporation to a limited liability company.

The Transaction is pro forma in nature as both Manhattan Telecommunications Corporation NJ and Manhattan Telecommunications NJ LLC are under common ownership and control and management. The Transaction will not result in any changes in Manhattan Telecommunications Corporation NJ's rates, terms or conditions of service and will be transparent to New Jersey customers. Therefore, Petitioners respectfully request expedited processing of the Petition.

In support of this Petition, Petitioners provide the following information:

I. BACKGROUND

Manhattan Telecommunications Corporation NJ was a privately held corporation organized pursuant to the laws of New Jersey whose principal business is telecommunications. Manhattan Telecommunications Corporation NJ was a wholly owned subsidiary of Manhattan Telecommunications Corporation LLC and indirect subsidiary of MetTel Holding, a privately held Delaware holding company. Manhattan Telecommunications Corporation NJ was authorized by the Board to provide local exchange telecommunications services on June 22, 2000, in Docket No. TE99120922 (the "NJ CPCN").

Manhattan Telecommunications NJ LLC is a privately held limited liability company organized pursuant to the laws of Delaware and formed solely for purposes of the Transaction. Manhattan Telecommunications NJ LLC is a wholly owned subsidiary of Manhattan Telecommunications Corporation LLC and indirect subsidiary of MetTel Holding. Attached hereto as **Exhibit A** are copies of Manhattan Telecommunications NJ LLC's Certificate of Formation and Certificate of Good Standing in New Jersey. Manhattan Telecommunications NJ LLC has the same ownership and management as Manhattan Telecommunications Corporation NJ.

MetTel Holding, through its subsidiaries, is a strategic partner providing a comprehensive suite of voice and data solutions as well as telecommunications consulting services to leading businesses nationwide. From traditional voice services to MPLS networks and Voice over IP technologies, MetTel Holding offers a complete portfolio of products.

In addition to the services provided by Manhattan Telecommunications Corporation NJ to New Jersey consumers, Manhattan Telecommunications Corporation NJ's affiliates are authorized by the

various state public service commissions to provide facilities-based and/or resold interexchange

telecommunications services, and competitive local exchange services in 49 other states, the District

of Columbia, Puerto Rico, and Canada, pursuant to certification, registration or tariff requirements, or

on a deregulated basis.

Further information regarding Manhattan Telecommunications Corporation NJ's legal,

technical, financial and managerial qualifications to provide telecommunications service to consumers

in New Jersey may be found in Manhattan Telecommunications Corporation NJ's initial application for

the NJ CPCN as a matter of public record. Petitioners respectfully request that the Board take official

notice of the information contained in the New Jersey application and incorporate it herein for

reference.

III. DESCRIPTION OF THE INTERNAL RESTRUCTURING

Manhattan Telecommunications NJ LLC seeks Board approval, to the extent necessary, of an

internal restructuring resulting from the conversion of all MetTel operating companies to Delaware

limited liability companies. In New Jersey, this conversion is accomplished through the merger of

Manhattan Telecommunications Corporation NJ with and into its newly formed affiliate, Manhattan

Telecommunications NJ LLC, a Delaware limited liability company, with Manhattan

Telecommunications NJ LLC being the surviving entity. Other than as described below, there will be

no change in the certificated entity's ownership, management, operation, rates or service offerings or

responsibility for regulatory obligations upon approval of this Petition. Manhattan Telecommunications

Corporation NJ invoiced customers under the name "MetTel" and Manhattan Telecommunications NJ

LLC will continue to invoice customers under the name "MetTel". Accordingly, the internal

restructuring is pro forma and will cause no confusion to customers.

In addition, upon completion of the conversion of all MetTel operating companies, an

intermediate holding company, MetTel PI, LLC, a Delaware limited liability company, was inserted

between Petitioners' parent company, MetTel Holding, and their ultimate parent company, MetTel,

Inc. This entity will be controlled by MetTel, Inc. It will be structured to permit other individuals or

entities to obtain purely economic rights, such as the right to participate in distributions above a

certain amount; however, these members will have no voting or management rights and all control

will remain with MetTel, Inc.

Following Board approval of this Petition, Manhattan Telecommunications NJ LLC will file

updated tariff(s) replacing Manhattan Telecommunications Corporation NJ's tariffs. The updated

tariffs will reflect the change in the name of the issuing entity only. All other rates, terms and conditions will remain the same as those in Manhattan Telecommunications Corporation NJ's current tariffs. Manhattan Telecommunications NJ LLC's managerial, technical, and financial qualifications that supported the grant of its CPCN to provide Local Exchange Telecommunications Services remain the same.

MetTel, Inc. is implementing this internal restructuring to streamline operations, facilitate financing and other transactions and for other business purposes. Accordingly, Petitioners respectfully request that the Board approve the Transaction expeditiously.

IV. PUBLIC INTEREST CONSIDERATIONS

As described above, the Transaction is in the public interest, because it will have no impact on Manhattan Telecommunications' customers and will promote Petitioners' corporate objectives. The corporate restructuring is necessary and appropriate, will not impair Manhattan Telecommunications NJ LLC's ability to offer telecommunication services to the public, and will promote the corporate purposes of Petitioners. The Transaction will not involve an assignment of the NJ CPCN or a change in the day-to-day operations of the certificated company. In addition, there will be no change in the services offered to Manhattan Telecommunications Corporation NJ's customers or the rates for Manhattan Telecommunications Corporation NJ's regulated services. The transaction will be completely transparent to Manhattan Telecommunications Corporation NJ's customers.

V. CONCLUSION

For the foregoing reasons, Petitioner submits that the public interest, convenience, and necessity would be furthered by grant of this Petition.
