The Office of Cable Television's and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval and attached application for the Township of Montville ("Township"). The following is a request for additional information the OCTV&T would like the company to furnish prior to the completion of our review:

- 1. Section I. Organization and Management Subsection 2: The application has listed the address as a 1 Court Square West, Long Island City, NY 11101. Staff notes that the previous address that was referenced in the current Renewal Certificate of Approval ("COA"), issued by the Board of Public Utilities ("BPU") in Docket No. CE08090701, is 40 Potash Road in the Borough of Oakland, New Jersey. Staff also notes that the telephone number was not provided. Please review and submit a revised application page with the system address and telephone number.
- 2. Section I. Organization and Management Subsection 13: This section of the application requires the company to list the address and telephone number of the designated local office or agent located within the system, available to receive, investigate and resolve any problems the subscriber may encounter. Staff notes that two offices are listed in the application; one at 765 Broad Street, Newark, New Jersey, and the other at 40 Potash Road, Oakland, New Jersey. Please provide a revised application page that clarifies the appropriate designated local office, within the system, to receive, investigate and resolve complaints.
- 3. <u>Section IV. System Design Subsection 3:</u> This section requires, in part, the company to provide information as to the number, cable channel designation, type of <u>access channels</u> and their manner of operation and channel sharing. Staff notes that this question was left blank in the application. The ordinance adopted on February 14, 2019, in SECTION 20. PUBLIC,

EDUCATION, AND GOVERNMENTAL ACCESS Subsection A, states the following "Cablevision shall continue to make available non-commercial public, educational and governmental (PEG) access services available to the residents of the Township as described in the Application for municipal consent...". Staff notes that previously the company provided two channels for PEG access purposes, located on channels 76 and 77. Please submit a revised application page that provides the information requested, which is applicable to the municipality and includes the channels specific information.

- 4. <u>Section IV. System Design Subsection 4:</u> This section of the application requires the company to list the type of channels, proposed inception, and cable channel designation that has been agreed upon between the municipality and company. Staff notes that part of the application question has been removed. Below is the complete question in the application, which can be found on the BPU Website. Please revise the application page appropriately.
 - 4. Each applicant shall title by category and list the following information concerning program origination;

5. <u>Section VI. System Design Subsection 5:</u> This section requires the company to provide information in narrative form, regarding production equipment and facilities to be made available by the applicant for the use of others in the community. Staff notes that specific information is needed for this section regarding the public access studio in New Jersey available for access users upon advance request. Please provide a revised application page which includes the address and telephone number for the public access studio.
