System Registered to ADI Program after PTO date was granted.

1.0 System Details:

1.1 Modules 11 – 425w Modules.

System Size DC – 4.68kW

Estimated Production 6,178kwh

Inverter 11 – Enphase IQ7

2.0 Background:

2.1 We are the installers of Lee Heims solar system and also sell their RECs for them. This project was initially sold during the closing of the Transition Incentive Program. It was never registered under said program, and was sold with the intention of being under the ADI Program. When sold, the ADI portal was not yet opened. The project moved forward with permitting and installation prior to Eznergy having the knowledge of where to submit for the new ADI Program. After PTO was granted, we sought out the proper means to have the customer's registration submitted to the BPU. Unfortunately, this meant that part one of the registration was not approved until after PTO was granted.

2.2 Dates in question for this project are as follows: Construction for this project commenced on May 19, 2022. Construction was completed May 21, 2022. PTO was granted July 20, 2022, and was backdated to July 13, 2022. ADI Program Part 1 Applications were submitted August 29, 2022, and was approved September 13, 2022. Part two applications were submitted September 15. We were alerted to the issue regarding N.J.A.C. 14:8-11.4 (b) Docket #QO20020184 on February 8, 2023.

3.0 In Conclusion

3.1 It is not fair that our customer must suffer for an oversight of a paperwork submission that has no effect on the system operating correctly. We are asking for you to take our unique circumstances into consideration and allow the registration to be processed and approved. We and our customer have not done anything to intentionally deceive or misuse the system to warrant such a harsh penalty.
