**PETITION**

Nudrat Ayub (“Petitioner”) by its undersigned counsel, respectfully petition the Board of Public Utilities (“Board”) as follows:

1. Pursuant to N.J.A.C. 14:1-1.2, the Petitioner respectfully requests a waiver of the requirement to submit a complete ADI program registration package and receive a Notice of Conditional Registration prior to beginning construction on the facility located at 8 Coventry Rd., Mendham, NJ 07945, NJADRE # 1550580526. This is a PV roof mount solar system installation.
2. The Petitioner seeks this waiver for the following reasons:
  - A. After investigation it was discovered that a former employee of Seapoint Solar who was responsible to apply for the program misunderstood the time line and submitted the paperwork with PTO after installation of the Petitioner’s solar system and without receiving Notice of Conditional Registration prior to commencement of construction.
  - B. The Petitioner should not be penalized for Seapoint Solar’s error and should

receive full credits and benefits associated with the Program.

- C. Seapoint Solar has installed and serviced many solar systems across the State and instances like this one have been rare. Seapoint Solar has put a system in place to prevent errors and oversights such as this one from occurring in the future.

### **CONCLUSION**

For all of the reasons set forth above, Petitioner respectfully requests that the Board issued a waiver of the requirement to submit a complete ADI program registration package and receive a Notice of Conditional Registration prior to beginning construction on the facility.
