**BACKGROUND AND PROCEDURAL HISTORY**

On November 9, 2022, Montague Water Company, Inc. and Montague Sewer Company, Inc., together with Corix Infrastructure (US) Inc. (“Corix US”), and SW Merger Acquisition Corp. (“SWMAC”) (collectively, “Joint Petitioners”), filed a petition with the New Jersey Board of Public Utilities (“Board”) requesting that the Board approve the proposed merger of SWMAC and Corix US (“Joint Petition”). According to the Joint Petitioners, the proposed merger would create a larger and stronger water and wastewater company.

By Order dated January 25, 2023, the Board retained the Joint Petition for hearing pursuant to N.J.S.A. 48:2-32 and designated me as the Presiding Commissioner authorized to rule on all motions arising during the pendency of these proceedings, as well as modify any schedules that may be set as necessary to secure a just and expeditious determination of the issues.<sup>1</sup> The Board also directed all entities seeking to intervene or participate to file the appropriate application with the Board on or before February 25, 2023, and that any party wishing to file for admission of

counsel *pro hac vice* do so concurrently.<sup>2</sup>

By Order dated March 27, 2023, I established the procedural schedule for this matter, which was annexed to the Order as Exhibit A (“March 27 Procedural Schedule”).<sup>3</sup> On May 12, 2023, I received correspondence from the Joint Petitioners seeking to amend the March 27 Procedural Schedule, specifically, by pushing the deadline for the New Jersey Division of Rate Counsel (“Rate Counsel”) to file testimony from May 15, 2023 to May 30, 2023, to allow for further settlement negotiations. Board Staff and Rate Counsel indicated they did not object to the amendment.

### **DISCUSSION AND FINDINGS**

I reviewed, in detail, the Joint Petitioners’ May 12, 2023 correspondence. To allow further settlement negotiations and to ensure an equitable determination of the issues, I **HEREBY AMEND** the March 27 Procedural Schedule and **HEREBY ORDER** that the Modified Procedural Schedule, a copy of which is affixed to this Order, supersedes the March 27 Procedural Schedule. I **FURTHER ORDER** that the attached Modified Procedural Schedule is controlling as of the date of this Order.

I **HEREBY DIRECT** that this Order be posted on the Board’s website.

This provisional ruling is subject to ratification or other alteration by the Board as it deems appropriate during the proceedings in this matter.
