Rockland Electric Company (the "Company" or "RECO") hereby submits for filing with the Board of Public Utilities (the "Board") 19th Revised Leaf No. 50 to its Schedule for Electric Service B.P.U. No. 3 – ELECTRICITY. This tariff leaf is issued May 31, 2023 to be effective June 1, 2023. This leaf is issued in compliance with the Board's Order dated May 24, 2023, in the above-referenced docket (the "May Order").

On March 31, 2023 the Company filed a petition with the Board requesting approval of tariff modification to add SC No. 1 Voluntary Time-of-Day ("TOD") Basic Generation Service ("BGS") rates for customers who take service under the SC No. 1 Voluntary TOD distribution rate. The Board approved those rates in the May Order. The purpose of this filing is to implement the Board's approved BGS SC No. 1 Voluntary TOD rates.

Please note that the Company is making this filing solely in electronic form pursuant to the Board's directive in its Emergency Order dated March 19, 2020 in BPU Docket No. EO20030254.
