2 COVID deaths reported in Beijing as virus surges

BEIJING - China's health authorities on Monday announced two COVID-19 deaths - the country's first reported fatalities in weeks - amid an expected surge of illnesses after it eased its strict "zero-COVID" approach.

Unofficial reports point to a widespread wave of new cases, and relatives of victims and people who work in the funeral business said deaths tied to COVID-19 were increasing. Those people spoke on condition of not being identified for fear of retribution.

Before Monday's two reported deaths - both in Beijing - China had not reported a death from COVID-19 since

With those fatalities, the National Health Commission raised China's total to 5,237 deaths from COVID-19 in the past three years, out of 380,453 cases of illness. Those numbers are much lower than in other major countries but also are based on statistics and information-gathering methods that have come into question.

Chinese health authorities count only those who died directly from CO-VID-19, excluding people whose underlying conditions such as diabetes and heart disease were worsened by the vi-

In many other countries, guidelines stipulate that any death where the coronavirus is a factor or contributor is counted as a COVID-19-related death.

China had long hailed its restrictive "zero-COVID" approach as keeping case numbers and deaths relatively low, comparing itself favorably to the U.S., where the death toll has topped 1.1 million.

Yet the policy of lockdowns, travel restrictions, mandatory testing and quarantines placed China's society and the national economy under enormous stress, apparently persuading the ruling Communist Party to heed outside advice and alter its strategy.

The easing began in November and accelerated after Beijing and several other cities saw protests over the restrictions that grew into calls for Presi-

dent Xi Jinping and the Communist Party to step down.

On Dec. 14, the government said it would stop reporting asymptomatic COVID-19 cases since they've become impossible to track with mass testing no longer required.

The lack of data has made it more difficult to grasp the scale of the outbreak or its direction. However, a major drop in economic activity and anecdotal evidence of the virus's spread point to a growing caseload, while health experts have projected a possible major wave of new infections and a spike in deaths over the next month or two.

China is trying to persuade reluctant seniors and others at risk to get vaccinated, apparently with only moderate success. The other major concern is shoring up health resources in smaller cities and the vast rural hinterland ahead of January's Lunar New Year travel rush, which will see migrant workers returning to their hometowns.

Numbers of fever clinics have been expanded in both urban and rural areas, and people have been asked to stay home unless seriously ill to preserve resources. Hospitals are also running short on staff, and reports say workers have been asked to return to their posts as long if not feverish.

Amtrak trains unveiled for 2026 **East Coast routes**

The public-private train company unveiled the more sustainable, spacious and upgraded train sets at a Thursday press conference in Moynihan Train Hall in Manhattan. The 83 new trains, which will replace 40- and 50-year-old fleets, will debut on 14 routes, including the Northeast Regional, Empire Service, Pennsylvanian and Ethan Allan Express, in 2026.

"As we invest in the future, Amtrak is leading the way with a new era of rail," said Amtrak President Roger Harris. "Our new trains will transform the Amtrak experience with significant environmental benefits, a progressive design and worldclass amenities."

These new trains, which are being purchased from California-based Siemens for \$7.3 billion, will not go considerably faster than the current ones, maxing out at 125 mph. Also, some speed limitations are contingent on signals and crossings, the older and less reliable of which require locomotive engineers to slow down.

The new Acela trains, which were supposed to hit the rails in spring 2021, are delayed until fall 2023 because of production issues and rigorous testing requirements for the higher-speed trains, which will reach 160 mph, according to The Washington Post.

New trains, which will be welcome additions for passengers returning to travel and as Amtrak sees growing numbers of new customers post-pandemic, should help improve service. But better service, especially on its most popular Northeast Corridor, will also require Amtrak to address its backlog of 115 capital projects that will cost \$117 billion, including the more than \$30 billion in Gateway projects that affect service into New York Penn Station.

Other routes that will benefit from the new trains in 2026 are: Virginia Services, Keystone Service, Downeaster, Cascades, Maple Leaf, New Haven/Springfield, Palmetto, Carolinian, Vermonter and Adirondack.

Here are the details of some of the state routes:

Northeast Regional

Multiple trips along the Northeast Corridor with stops in Boston; Providence; Springfield; Massachusetts; Hartford; New York; Newark, Philadelphia and Washington, D.C. It continues through the following stops in Virginia: Roanoke, Richmond, Norfolk, Newport News and Virginia Beach.

Empire Service

Travels between New York City, Albany, Syracuse, Rochester, Buffalo and Niagara Falls.

Adirondack

This line offers service from New York City through the Hudson Valley and Albany to Montreal.

Ethan Allen Express

Daily service from New York City to Vermont through the Hudson Valley and

Keystone

"Frequent" daily service between New York City and Harrisburg by way of Philadelphia.

Pennsylvanian

Daily service between New York City and Pittsburgh, with stops in Trenton, Philadelphia and Harrisburg.

PLEASE TAKE NOTICE that on September 13, 2022, New Jersey Natural Gas Company ("NJNG" or the "Company") filed its annual Societal Benefits Charge ("SBC") petition with the New Jersey Board of Public Utilities ("Board") for a price adjustment for all applicable service customers. Pursuant to its filing, NJNG requested that the Board permit NJNG to increase its overall SBC rate which would include an increase to the Remediation Adjustment ("RA") and increase to the New Jersey Clean Energy Program ("NJCEP") factors effective April 1, 2023.

The RA rate provides recovery of actual costs incurred by NJNG for the clean-up of former manufactured gas plant sites. The NJCEP rate is designed to recover costs incurred for NJNG's share of statewide energy efficiency and renewable energy expenditures.

If approved, the impact will result in an overall increase of approximately \$0.88 per month or approximately 0.56 percent for a typical residential heating customer using 100 therms per month. The above-referenced proposal will not result in any profit for NJNG.

If approved by the Board, the impact of the proposed changes to the RA and NJCEP factors on typical natural gas bills is illustrated below:

Therefore, the Board may establish the RA and NJCEP factors at levels other than those proposed by NJNG. NJNG's SBC costs addressed in this petition will remain subject to audit by the Board, and Board approval shall not preclude or prohibit the Board from taking any such actions deemed appropriate as a result of any such audit.
