RE: Request for Extension to Set #1 Clarifying Information Submission Deadline¹

Dear New Jersey Board of Public Utilities,

On August 4, 2023, Attentive Energy LLC (“Attentive Energy”) submitted an application (our “Application”) in response to the New Jersey Board of Public Utilities (“BPU”)’s third Offshore Wind Solicitation (the “Third Solicitation”). Attentive Energy received on behalf of BPU through its contractor, Levitan & Associates, Inc., Clarifying Questions Set 1 (the “Clarifying Questions”) for the Third Solicitation on September 1, 2023. BPU has requested that Attentive Energy provide responses to the Clarifying Questions by 5:00 pm Eastern Time on September 11, 2023 (the “Set #1 Clarifying Information Submission Deadline”).

Attentive Energy’s treatment of direct jobs and spending in our Application was guided by the Third Solicitation Guidance Document and formal responses by BPU to Questions and Answers submitted by developers and other interested stakeholders (“Q&A”). The Clarifying Questions contain different interpretations of what may be considered direct jobs and spending from what Attentive Energy understood to be BPU’s interpretations based on Solicitation Guidance Document and formal responses by the BPU in the Q&As.
