Dear Mayor Nametko:

Our records indicate that our cable television franchise is due to expire on September 5, 2018. We, of course, wish to continue providing service to the Borough of Netcong for an additional renewal term, and are, by this letter, informing you of our intention to seek renewal of the franchise.

The Cable Communications Policy Act of 1984 and the Cable Television Consumer Protection Act of 1992 establish formal cable television renewal procedures to be invoked 30-36 months prior to expiration. Accordingly, as provided for in Section 626 (a), we hereby request the Borough of Netcong to commence renewal proceedings set forth in Section 626 subsection (b) through (g). (A copy of Section 626 is attached for your use.)

The Cable Acts also allow for reaching mutually beneficial agreement for franchise renewal through informal negotiation, if both parties wish to undertake these discussions. We would be ready at any time during these formal proceedings to discuss the terms of renewal with you on an informal basis. We believe such negotiations would be successful and cost-effective -- allowing us to discuss the needs of the community and the future of cable service without the involved procedures. Of course, if we agree to a temporary delay in the formal procedures in order to explore informal negotiations, both parties will retain their rights to proceed with the formal renewal process at any time upon written notice to the other party.

We are proud to serve the residents of Netcong and look forward to working with you on this renewal and into the future.
