RE: Attentive Energy LLC Response to Clarifying Questions Set 1, Received on September 1, 2023 (part 1 of 2)

Dear Board Staff and Levitan & Associates,

Attentive Energy LLC (“Attentive Energy”) is excited to have the opportunity to provide the New Jersey Board of Public Utilities (“BPU”) with additional information regarding its Attentive Energy Two Project (the “Project”) submission into BPU’s third offshore wind solicitation. The Project will supply the State of New Jersey with up to 1,342 megawatts (“MW”) of clean and renewable wind energy, and it is expected to power more than 600,000 homes and generate up to \$12 billion in economic activity. Additionally, Attentive Energy Two will help the State prepare for the impacts of climate change and pave the way for New Jersey to achieve its greenhouse gas emissions targets while creating economic opportunities for communities statewide and prioritizing affordability for ratepayers. Attentive Energy, through Sponsors TotalEnergies and Corio, has deep global offshore development and operating experience, combined with a track record of investing in and partnering with local communities in the State through decades of respective company footprints in New Jersey. This Project will continue this track record of economic development by delivering up to 15,000 job-years for New Jersey residents.

Attentive Energy respectfully provides the following responses to BPU’s letter dated September 1, 2023 providing Clarifying Questions Set 1 for Attentive Energy’s Application submitted in response to BPU’s third offshore wind solicitation.<sup>1</sup> This letter contains responses to the first part of Clarifying Questions Set 1. With respect to information regarding direct jobs and spending, the BPU granted an extension to the Set #1 Clarifying Information Submission Deadline to 5:00 pm Eastern Time on September 18, 2023. Responses to questions regarding direct jobs and spending (namely, questions 3, 4, 5, 6, 8, 10, 14, 15, 16) will be provided by that extended deadline.

### Economic Development Plan

**1. Section 8.1: The first paragraph of this section states that Attentive Energy expects to deliver up to \$12 billion in economic benefits and jobs. The graphic under the first paragraph of this same section states that Attentive Energy expects to deliver up to \$15 billion in economic benefits and jobs. Please clarify the difference between these two numbers.**

Attentive Energy confirms that the reference to \$15 billion in the infographic in Section 8.1 (page 8-2) is a typographical error. This error was identified in Attentive Energy's deficiency notice response letter submitted on September 1, 2023, explaining that the infographic should instead reference a total of up to \$12 billion in economic benefits and jobs to New Jersey over the lifetime of the Project, therefore matching the text in the first paragraph of Section 8.1.

**a. Please clarify whether Attentive Energy's IMPLAN analysis used the unmodified total spend, labor spend, and job-year values provided by vendors. If not, identify any modifications made to the unmodified total spend, labor spend, and job-year values provided by vendors to arrive at the values that were used in IMPLAN.**

Attentive Energy's economic benefits for all Project options are based on information received directly from vendors and the extensive internal databases of the Sponsors, TotalEnergies and Corio, who have supply chain relationships in the U.S. and the offshore energy industry globally. [REDACTED]

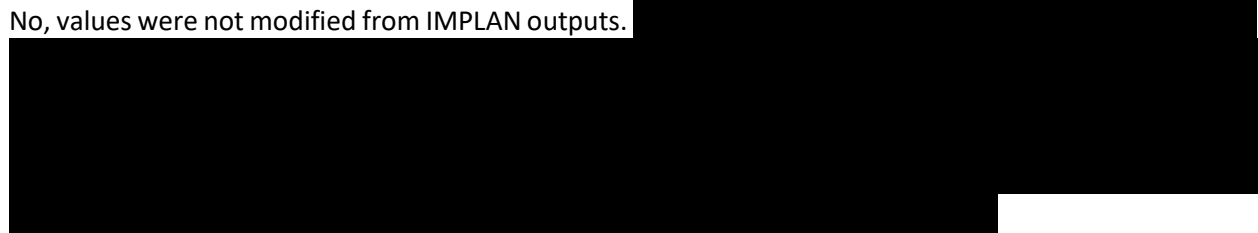
**b. Did Attentive Energy use the guaranteed total spend and job-year values or some other set of values as inputs to IMPLAN?**

For its Application, Attentive Energy modeled expected spend, not guaranteed spend, in IMPLAN. Attentive Energy then identified guaranteed total spend and job-year values as a subset of the expected

spend calculated, based upon Attentive Energy’s evaluation of New Jersey’s current and forecasted capabilities for each specific package and spend.

**c. Other than converting from IMPLAN’s definition of an FTE-year as 2,080 hours to the NJBPU’s definition of an FTE-year as 1,820 hours, are the values presented in these tables modified from the outputs from IMPLAN? If yes, please identify any modifications made to the IMPLAN outputs to arrive at the values in these tables.**

No, values were not modified from IMPLAN outputs.

**11. Attachment 8-A: The job guarantee values stated in the Application Form are in FTE-years, but the columns in the Attachment are labeled as FTEs. Please confirm the correct units for the job guarantee values.**

Attentive Energy confirms that the unit label for the columns titled “In-State Job Creation” within Table 1 and Table 2 of Attachment 8-A is a typographical error. The label should be FTE-years, not FTEs.

**12. Section 13.1.4: Please provide GIS shapefiles associated with your export cable route(s), including onshore and offshore, as shown in Figure 13-1.**

Attentive Energy has provided a zip folder that includes indicative offshore and onshore routes and labelled, “12. Confidential Onshore and Offshore Route GIS Shapefiles.zip”. This confidential zip folder

was uploaded to the portal on September 6, 2023 at the New Jersey Offshore Wind Team's request<sup>2</sup> to provide the files before the response deadline to Clarifying Questions Set 1. The zip folder also contains the reference Geodesy sheet used for these shapefiles. As stated in the Application Narrative, these are indicative routes that will be further refined based upon results of Attentive Energy's survey campaigns and throughout the Project's detailed engineering phases in the coming years.
