The Office of Cable Television and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval ("COA") and attached application for the Borough of Netcong ("Borough"). The following is a request for additional information the OCTV&T would like the company to furnish prior to the completion of our review:

1. **Section IX. Line Extension Policy:** The municipal consent application attached a Commercial Line Extension Rate Policy. However, the adopted Ordinance at SECTION 8. EXTENSION OF SERVICE states in part, "Commercial and residential entities will be proffered service in accordance with the Company's line extension policy as identified in the Application." The COA application has the OCTV&T's Line Extension Policy ("LEP"), but did not contain a Commercial Line Extension Policy. Kindly provide a Commercial LEP to be used in the Borough in addition to the residential LEP that was provided with the application.
