By letter dated April 25, 2024, we submitted a signed stipulation of settlement of the above-captioned matter for consideration by Your Honor and the Commissioners of the Board of Public Utilities.

It has since come to our attention that a transposition of numbers resulted in the figure in paragraph number one on page six of the stipulation to be represented as \$14,402,102 instead of \$14,204,102 as it should have been, and as correctly represented in Attachment A to the stipulation. The remainder of the stipulation is accurate as presented.

With the signatory parties' permission, we respectfully request that the enclosed, corrected stipulation of settlement be substituted for the version filed on April 25, 2024.
