I understand that PSEG initiated a rate case filing on December 29, 2023, which will increase the monthly charges for street lighting by 10% at some point in 2024 - 2025. I would like to formally submit this in anticipation of the hearing.

As an observant citizen with a passion for street lighting I bring the attached letter to your attention. Street lighting in our state is not being maintained to the standards detailed in NJAC 14:15-2.9(b) which requires that.

"All routine streetlight repairs are to be made within three business days after notice that a repair is necessary." "Other more extensive repairs including, but not limited to, those requiring excavation, shall be handled on a best-efforts basis in order to ensure the restoration of safe, adequate and proper service as quickly as reasonably possible."

Frankly, PSEG is distant from meeting the three-business day goal for routine repairs. Furthermore, anything requiring "<u>more extensive repairs</u>" extends months if not years. Those are the facts. At issue is the manner and magnitude of these "best-efforts basis" which is clearly a consequence of the (non) allocation of resources by the petitioner.

I respectfully request that this factor be included among the considerations before the Counsel and BPU when considering PSEG's latest request.

Subject: <u>Extended duration of Street light repairs in Newark (and Trenton too)</u>

Thank you for rolling out a major upgrade which enables customers to report street light outages on a map which meshes several alternative views. This was a serious step forward. While there remain "kinks" to be ironed out in mapping the assets (street light poles) onto the aerial photo imaging this is a dramatic improvement. On to the main subject of this letter which is based on tracking <u>chronic</u> streetlamp outages since 2017.

Frankly, anything more than replacing a burnt-out bulb or swapping a defective cobra head with a new LED head slowly descends into oblivion. Repair orders get lost in PSEG's repair processes. You do not need "citizen Rob" "PEG stockholder Rob" to inform you that this is not good. Currently a streetlight can and does remain out of service for months, if not years, if not forever while awaiting some sort of repair. This is inexcusable for an award-winning utility company.

This is not what the State's Board of Public Utilities or legislature had in mind when enacting NJAC 14:15-2.9(b) which requires that.

"All routine streetlight repairs are to be made within three business days after notice that a repair is necessary." "Other more extensive repairs including, but not limited to, those requiring excavation, shall be handled on a best-efforts basis in order to ensure the restoration of safe, adequate and proper service as quickly as reasonably possible."

When I consulted with BPU staff about this situation in April 2023 they suggested that I make a submission of my findings within an upcoming rate case filing. I understand that PSEG has made a filing on December 29, 2023 (ER23120924).

The attached tracking table is for your review and consideration. With over \$^1475,000\$ streetlamps it is reasonable to, to assume a certain percentage of "outliers" which require "extended treatment" and additional resources to repair them. Thank you for your February 27, 2020 correspondence to the New Jersey Board of Public Utilities ("Board") regarding street lighting. Your inquiry was forwarded to the Division of Energy within the Board for a response related to street lighting.

N.J.A.C. 14:5-2.9 (b) requires all routine streetlight repairs which include bulbs, fixtures, globes, mantles or photocells to be made within (3) three business days after notice that a repair is necessary. More expensive repairs which may require excavation should be made as quickly as reasonably possible in order to ensure the restoration of safe, adequate, and proper service.

# § 14:5-2.9 Inspection of property

- **(a)** Each EDC shall inspect lamps and street lighting accessories and maintain such service in accordance with N.J.A.C. 14:3-2.7(a) and established industry practice. Whenever any transformers, high tension insulators, and equipment are removed from the system for any reason they shall be inspected as to safety and serviceability before being reinstalled in the same or other location.
- **(b)** All routine streetlight repairs are to be made within three business days after notice that a repair is necessary. Routine repairs include bulbs, fixtures, globes, mantles or photocells. Other more extensive repairs including, but not limited to, those requiring excavation, shall be handled on a best efforts basis in order to ensure the restoration of safe, adequate and proper service as quickly as reasonably possible.

### § 14:5-8.13 Penalties

- (a) Civil administrative penalties for violations of the reporting and planning and program submission requirements set out in N.J.A.C. 14:5-8.3 through 8.9 and 8.11 shall be assessed as follows:
  - 1. For failure to submit complete required reports, programs and plans on the due date set by rule, the EDC may be liable for a penalty of up to \$ 5,000 for each day beyond the due date that the report, program or plan is not submitted, up to a maximum of \$ 25,000 in total penalties for each violation; provided, however, that upon timely written request to Board staff demonstrating the need for an extension of time, the time for submitting required reports, plans and programs may be extended in appropriate cases.
  - 2. A second or any subsequent failure to submit any required report, plan or program, the EDC may be liable for a penalty of up to \$ 50,000.
- (b) Civil administrative penalties for violations of this subchapter other than those set out in (a) above may be assessed as follows:
  - 1. For failure to implement the requirements set out in the programs and plans as submitted to the Board or for the willful misrepresentation of fact and/or intentional inaccuracies in any submitted report, plan or program or for violation of any other requirement of this subchapter, an EDC may be liable for a penalty of not more than \$ 25,000 for each violation unless mitigating circumstances can be demonstrated by the EDC. For a second or any subsequent violation of the same provision, the EDC may be liable for a penalty of not more than \$ 50,000.
  - 2. Each violation of any rule of this subchapter shall constitute an additional, separate and distinct violation.
  - 3. Each day during which a violation continues shall constitute an additional, separate and distinct violation.
- (c) Any penalty which may be assessed under this section may be compromised by the Board. In determining the amount of the penalty, or the amount agreed upon in compromise, the Board may consider aggravating and mitigating circumstances including the nature and gravity of the violation; the degree of the EDC's culpability; any history of prior violations; and any good faith effort on the part of the EDC in attempting to achieve compliance.
- (d) Penalty assessments are payable to the Treasurer, State of New Jersey and are due within 30 days of service upon the EDC of an order assessing a penalty unless the Board directs otherwise.
