Dear Secretary Golden:

We write to inform you on behalf of Comcast of South Jersey, LLC ("Comcast") that, in response to a letter from Staff dated March 7, 2023 (the "March 7 Letter") and pursuant to the interim e-filing procedures adopted by the New Jersey Board of Public Utilities (the "Board") on March 19, 2020, we have submitted a confidential and a public filing via the Board's e-filing portal (the "Portal") in connection with the above-referenced matter. The filed materials further supplement (i) a copy of correspondence with the City of Vineland confirming that Comcast provided the City with a one-time technology grant, which correspondence was sent via email to Staff on or around December 14, 2023 in response to item 9 in the March 7 Letter; (ii) a digital copy of the system map (the "Map") for the City of Vineland that was furnished to Staff on or around December 14, 2023, in response to an email request from Staff dated July 25, 2023; and (iii) a physical copy of the Map, whose receipt was acknowledged by Staff in an email dated January 4, 2024.

The confidential filing submitted today via the Portal includes a copy of this letter; a confidential and unredacted version of revised and additional application materials (the "Supplement") to supplement the application previously submitted in connection with this matter; and the affidavit of Fred DeAndrea, Comcast's Senior Director of Government and Regulatory Affairs, in support of our request for confidential treatment of certain information in the Supplement (the "Affidavit"). The public filing submitted via the Portal comprises a copy of this letter; the Affidavit; and a version

of the Supplement with the confidential information having been redacted therefrom (collectively, the "Public Filing").

We have also sent a copy of the Public Filing via email to Keith Petrosky, Municipal Clerk for the City of Vineland.

In accordance with N.J.A.C. 14:1-12 et seq., Comcast respectfully submits that certain designated information in the Supplement is proprietary commercial information. Accordingly, the Application does not constitute a government record under the New Jersey Open Public Records Act, P.L. 2001, c. 404 (N.J.S.A. 47:1A-1 et seq.) and is exempt from public disclosure. The Affidavit of Mr. DeAndrea filed simultaneously herewith substantiates Comcast's request for confidential treatment.
