NOTICE OF FILING AND PUBLIC HEARINGS

IN THE MATTER OF THE PETITION OF ELIZABETHTOWN GAS COMPANY FOR APPROVAL OF A RATE ADJUSTMENT PURSUANT TO THE INFRASTRUCTURE INVESTMENT PROGRAM ("IIP") BPU Docket No. GR24040281

PLEASE TAKE NOTICE that on April 30, 2024, as modified on July 15, 2024, Elizabethtown Gas Company ("Elizabethtown" or "Company") filed a petition with the New Jersey Board of Public Utilities ("Board") seeking Board approval to increase rates associated with the Company's Infrastructure Investment Program ("IIP") ("Petition"). By Order dated June 12, 2019, the Board approved the IIP and the associated cost recovery mechanism ("Order").¹ The Order authorized the Company to invest up to \$300 million, over a five (5)-year period commencing July 1, 2019 and ending June 30, 2024, to replace up to 250 miles of cast iron and bare steel mains and related services, as well as the installation of excess flow valves on new service lines ("IIP Projects"). The Order also authorized the Company to make annual filings with the Board to recover the costs associated with the IIP Projects investments and to earn a return on and of those investments through annual adjustments to rates. By the Petition, the Company seeks Board approval to recover \$6.2 million of revenue requirements associated with approximately \$58.0 million of IIP Projects placed in-service from July 1, 2023 through June 30, 2024 through rates effective October 1, 2024. The IIP Projects are intended to enhance distribution safety and reliability to the benefit of Elizabethtown's customers. The Company also believes that the IIP supports the environment, and facilitates economic development and employment in New Jersey.

If approved by the Board, the per therm rates, inclusive of taxes, to all firm customers served under Service Classifications RDS, SGS, GDS, NGV, LVD, EGF, and GLS, including certain firm, Boardapproved special contract customers served under the Company's firm rate classes, would be as follows:

The impact of the proposed increase to rates in effect on July 1, 2024 for a residential heating customer using 100 therms per month would be an increase to the customer's monthly bill of \$1.74 from \$138.93 to \$140.67, an increase of 1.3%.

The Board has the statutory authority, pursuant to <u>N.J.S.A.</u> 48:2-21, to approve and establish these tariff classifications and rates at levels it finds just and reasonable as well as to establish the effective date of such rates. Therefore, the Board may establish these rates at levels and/or an effective date other than those proposed by Elizabethtown.
