Dear Secretary Golden:

On behalf of New Jersey-American Water Company, Inc., enclosed are revised tariff leaves submitted in compliance with the Board's September 4, 2024 Order in the above referenced matter.

Please note that the tariff leaves differ from Attachment C to the Stipulation of Settlement in the following respects:

1. The Fixed Service Charge on Rate Schedule 19-A has been changed from \$5.00 to \$5.15 as reflected in the proof of revenues;
2. Rate Schedule 13-A for wastewater service to the Borough of Mount Ephraim now properly reflects the inclusion of the Special Program Charge (SPC) as shown on Rate Schedule O-3;
3. Rate Schedule 21-A for wastewater service to the former Environmental Disposal Corp. service area now properly reflects the inclusion of the SPC as shown on Rate Schedule O-3, and the Wastewater System Improvement Charge (WSIC), as shown on Rate Schedule 9-A.1; and
4. Rate Schedules O-3 (SPC) and 9-A.1 (WSIC) have been revised to include applicability to Rate Schedule 21-A.

We have consulted with Board Staff and the Division of Rate Counsel regarding this filing.
