PLEASE TAKE NOTICE that on July 31, 2024, Elizabethtown Gas Company ("Company" or "Elizabethtown") filed a petition with the New Jersey Board of Public Utilities ("BPU" or "Board") to adjust the Remediation Adjustment Clause ("RAC") component of its Societal Benefits Charge ("SBC") rate ("Petition"). The Company's SBC rate consists of four (4) components: 1) the New Jersey Clean Energy Program ("CEP") component which recovers the costs of statewide energy efficiency and renewable energy programs mandated by the Board; 2) the RAC, which allows the Company to recover from ratepayers the cost related to environmental remediation of former Manufactured Gas Plants; 3) the Universal Service Fund, which provides assistance to qualifying low-income customers with paying their energy bills; and (4) the Lifeline program, which provides assistance with heating costs to qualifying low-income elderly and disabled customers. In its Petition, the Company requests to increase the per therm RAC rate from \$0.0225 to \$0.0303, inclusive of applicable taxes, to be made effective October 1, 2024. A comparison of the Company's current rate to the proposed rate is as follows:
