Ordinance. A copy of said correspondence is attached hereto as **Exhibit E**.

5. Cablevision maintains a local office for the use of its customers at 275 Centennial

Avenue, Piscataway, NJ 08854.

6. Cablevision has been operating its cable system within the Municipality in

compliance with applicable federal and state law and in conformance with the rules, regulations

and orders of the Board. Cablevision has fulfilled its material commitments set forth in the

existing Certificate of Approval.

7. The granting of the within Petition for renewal of Cablevision's Certificate of

Approval is necessary and proper for the public convenience and will serve the public interest as

Cablevision has the financial, legal and technical ability to provide the proposed cable services

during the term of the renewal.
