Dear Mayor Henry:

I write on behalf of CSC TKR, LLC d/b/a Cablevision of Raritan Valley, a subsidiary of Altice USA, Inc. (collectively "Altice USA" or "the Company") to let you know that our cable television franchise with the City of South Amboy is due to expire on August 18, 2021. Altice, of course, wants to continue providing service to South Amboy for an additional renewal term, and is, by this letter, informing you of its intention to seek renewal of the franchise.

The Cable Communications Policy Act of 1984 and the Cable Television Consumer Protection Act of 1992 establish cable television renewal procedures to be invoked 30-36 months prior to expiration. Accordingly, as provided for in Section 626(a), we hereby request the City of South Amboy to commence renewal proceedings set forth in Section 626 subsection (a) through (g). (A copy of Section 626 is attached for your use.)

The Cable Acts allow for reaching mutually beneficial agreement for franchise renewal through informal negotiation. Altice and the City of South Amboy undertook the informal process during the last franchise renewal, and we would be ready to once again discuss the terms of renewal with you on an informal basis. We believe such negotiations would be successful and cost-effective, allowing us to discuss the needs of the community and the future of cable service in the City of South Amboy without the involved formal procedures.

We are proud to serve the residents of South Amboy and look forward to working with you on this renewal and into the future.
