**PLEASE TAKE NOTICE** that on September 9, 2024, New Jersey-American Water Company, Inc. (“NJAWC”) filed a petition with the New Jersey Board of Public Utilities (“Board”) pursuant to N.J.S.A. 48:2-14, N.J.S.A. 48:19-17, N.J.S.A. 48:19-20, and N.J.A.C. 14:1-5.5, and such other regulations and statutes as may be deemed applicable and appropriate, to approve a municipal consent ordinance (“Ordinance 2024-06”) granted to NJAWC (“Petition”) by the Township of Hillsborough (“Township”).

The Township adopted Ordinance 2024-06 on June 11, 2024, pursuant to N.J.S.A. 48:3-11 to 15, and N.J.S.A. 48:13-11, thereby granting municipal consent to NJAWC to construct, lay, maintain and operate the necessary wastewater mains, pipes and appurtenances in a portion of the Township to provide wastewater collection services to that portion of the Township formerly served by the Borough of Manville.

NO INCREASE IN RATES WILL RESULT FROM THE PETITION.
